### STANDARD CONDITIONS

1. Any unauthorized alterations to this permit shall invalidate it.
2. The holder of this permit shall at the request of a person authorized in terms of the relevant legislation so to demand, forthwith produce such permit to such person.
3. The holder of this permit shall return this original permit to the director: Wildlife Trade & Regulation, Limpopo Province, P.O. Box 55464, Polokwane, 0700
4. The MEC may withdraw any such permit if the holder of the permit contravenes or fails to comply with a condition subject to which the permit was issued.
5. The permit holder may only act as a Professional Hunter whilst he or she is in the employ of a Hunting Outfitter.
6. This permit remains the property of the department.
7. This permit shall be invalid until such time that it is signed by the permit holder
8. This permit shall lapse when its lost or destroyed and no copy thereof shall be issued.
9. This permit shall not be transferable.
10. This permit shall be subject to the provisions of any law in force, and or Norms and Standards, of the permit in the area to which the permit to such person.
11. The permit holder shall submit within a period of fourteen days after the end of the hunt, the second copy of the hunting agreement of the hunt as per IPHCC Policy, to the Director: Wildlife Trade and Regulation, P.O. Box 55464, Polokwane, 0699.
12. The permit holder may escort a client on land of which the Hunting Outfitter who organize a hunt for a client on land of which the Hunting Outfitter is the owner , or in respect of the hunting rights, that have been transferred to the Hunting Outfitter.

### SPECIAL CONDITIONS

1. Unrestricted: The permit only authorize the professional Hunter to hunt specially protected wild animals, protected wild animals and game, INCLUDING: African Elephant, White Rhinoceros, Black Rhinoceros, Lion, Leopard and Buffalo.
